ADDITION RATES

Dosage rates vary dependant on mix design, process, aggregate type and the desired effect but typically:

200mls - 800mls per 100 kg cement (0.20% - 0.80% by weight of cement)

COMPATIBILITY

Sigma 190 is compatable with all types of EN197 cement systems.

Sigma 190 should not be pre-mixed with other admixtures and should be batched seperately.

STORAGE

Sigma 190 should be stored undercover and protected from extreme temperatures, if stored between the range 5°C to 30°C the product will have a minimum shelf life of 12 months.

HANDLING

Please refer to the **Sigma 190** material safety data sheet but in line with normal handling procedures, personal protective equipment should be worn.

NOTES

Sigma 190 should be added with the water or at the end of the mixing process and not directly onto the cement. A mixing time of at least 30 seconds is recommended after the addition of the admixture.

If frozen **Sigma 190** may be used after thawing slowly at room temperature followed by intensive remixing.
